

# Privacy Policy

## Introduction

Youmi Technology (HK) Limited and Youmi entities (“Youmi”, “we/our/us”) provides this Privacy Policy to inform users (“you” or “ users”) of our policies and procedures regarding the collection, use and disclosure of your information (including personally information) received from our users and this Website <https://www.appgrowing.net/>(collectively, the “Services” or the “Website”) collected via the Website, email, SMS, telephone, WAP or other means. This Privacy Policy may be updated from time to time for any reason, at our sole discretion. We will notify you of any changes to our Privacy Policy by posting the new Privacy Policy on our Website. You are advised to consult this Privacy Policy regularly for any changes. By using or accessing to the Website or the Services, you are accepting the terms in this Privacy Policy, and you are consenting to our processing of your information as set forth in this Privacy Policy now and as amended by us. If you do not agree to this privacy policy, please do not use the services immediately.

This Privacy Policy of the Website applies to information collection and use including while you are visiting and using the Site.

## Collection and Use Information

We collect personally information (“Personal Data”) that you have provided to us through the Services including, without limitation, information that you provide on a registration page, information by a request, a request for access to the Services, a registration for an event, a forum or bulletin board, or an order form, etc. We use the Personal Data that we collect in order to provide and improve our services, and as otherwise set forth in this Privacy Policy. The Personal Data we collect may include first name, last name, address, email address, telephone number, billing and credit card information. We are entitled to take measures to validate the authenticity of personal information you provide. If you give us personal information of somebody else, we will assume that you have their permission to do so. Transmissions to and from this Site may not be confidential and consequently, may be read or intercepted by others.

As you navigate the Website, we may also collect information through the commonly use of information-gathering tools, such as cookies and Web beacons (“Website Navigational Information”). Website Navigational

Information includes standard information from your Web browser (such as browser type and browser language), your Internet Protocol (“IP”) address, and the actions you take on the Website (such as the Web pages viewed and the links clicked).

## Use of Collected Information

We use the Personal Data you provide in a manner that is consistent with this Privacy Policy. If you provide Personal Data for a certain reason, we may use the Personal Data in connection with the reason for which it was provided. For instance, when we receive your Personal Data that you have registered about your mailbox or address, we may use that Personal Data in order to contact you (via email or otherwise). We and our affiliates also use your Personal Data and other non-personally-identifiable information collected through the Website to help us improve the content and functionality of the Website, to better know the users of our Website, and to improve our services.

We may also use any of your personal information in this Privacy Policy for the purposes of: (I) enforcing our agreements and policies, (II) protecting or defending our legal rights; (III) protecting your vital interests or the vital interests of another natural person; or (IV) complying with legal obligations.

## Aggregation of Personal Data

In an ongoing effort to better understand our users, we may analyze the Personal Data that is provided to the Website in aggregate form. This aggregated information does not identify you personally. We may share this aggregated data with our affiliates, agents and business partners. We may also disclose statistics of this aggregated information in order to describe our services to our current and potential business partners, and to other third parties for lawful purposes.

## Disclosure of Your Personal Data

We may use selected third parties (“partner”) to provide us with services, including companies that assist with programming and technical aspects of hosting and operating the Website, who may have access to your personal data. Our affiliates may also have access to your personal data including through or in connection with this Site for the purposes set out in this Privacy Policy.

The servers used in the operation of the Website automatically identify a computer by its IP address. Although, we will not be able to identify the

computer using its IP address once you have left the Website. If we, in good faith, determine that you have or are attempting to misuse or harm the Website, we may investigate and cooperate with appropriate law enforcement agencies to protect our rights or property.

We may share your personal data as required or permitted by law to comply with a subpoena or similar legal process or government request, or when we believe in good faith that disclosure is legally required or otherwise necessary to protect our rights and property, or the rights, property or safety of others, including to advisers, law enforcement agencies, judicial and regulatory authorities. ## International Transfers

You hereby expressly consent to the transfer of your personal information to recipients, as described in this Privacy Policy, which are located outside the EEA.

## Rights of Your

We provide you with some certain abilities to choose and control your information in connection with our treatment. ## Children

We take precautions to ensure the security of your Personal Data. However, we cannot guarantee that hackers or unauthorized personnel will not gain access to your Personal Data despite our efforts.
